FAMILY CHILD CARE FOOD PROGRAM: WE EMPOWER FAMILY CHILD CARE PROVIDERS TO ENSURE THAT YOUNG CHILDREN (TWELVE YEARS OF AGE AND UNDER) HAVE ACCESS TO HEALTHY USDA FUNDED FOOD, EDUCATIONAL MATERIALS AND QUALITY CHILD CARE TO HELP ENSURE SUCCESS IN SCHOOL. AS A CHILD AND ADULT CARE FOOD PROGRAM SPONSOR, WE TRAINED AND MONITORED MORE THAN 2,300 FAMILY CHILD CARE PROVIDERS WHO, IN TURN, FED MORE THAN 22,300 CHILDREN. THIS AMOUNTS TO MORE THAN 10 MILLION HEALTHY MEALS AND SNACKS SERVED DURING THE YEAR IN 76 OHIO COUNTIES. WE FOCUS PRIMARILY ON LOW AND MODERATE INCOME FAMILIES AS WELL AS THE NEWLY IMMIGRATED.

SCHOOL AND SUMMER NUTRITION: WE WORK WITH SCHOOLS, COMMUNITY GROUPS, AND FAITH-BASED YOUTH-SERVING ORGANIZATIONS ACROSS THE STATE TO EXPAND PARTICIPATION IN CHILD NUTRITION PROGRAMS, SUCH AS NATIONAL SCHOOL BREAKFAST AND SUMMER MEALS BY RAISING AWARENESS OF THE IMPACT OF CHILDHOOD HUNGER ON DEVELOPMENT, HEALTH, AND LEARNING. CHA TARGETS GEOGRAPHIC AND DEMOGRAPHIC AREAS OF NEED IN ALL 88 OHIO COUNTIES, LINKS FOOD TO LEARNING, AND SUPPORTS NEW AND EXISTING FOOD PROGRAMS. 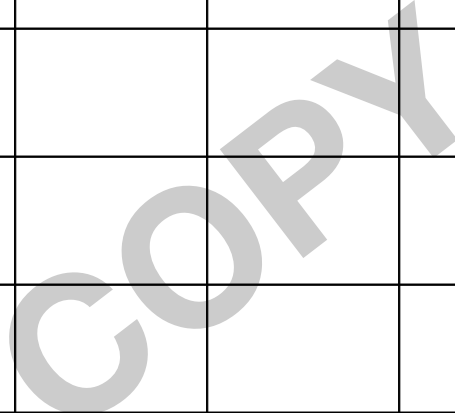

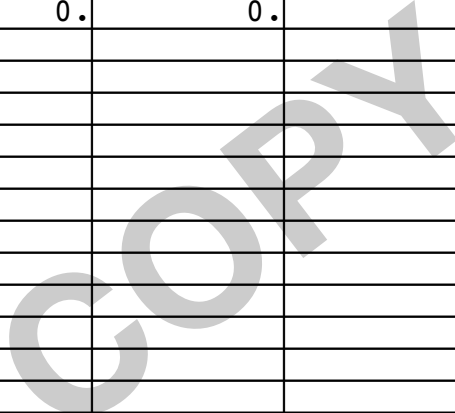
